

Southwind Farms Boarding Agreement

1. A current negative Coggins Test MUST accompany all horses shipped to Southwind Farm for boarding purposes.
2. Our vaccination requirements are as follows: Potomac Horse Fever, Botulism, Rhinopneumonitis, Encephalomyelitis, Tetanus, Influenza, Strangles, and rabies. If your horse(s) arrives at our farm without a vaccination chart, your horse(s) will be vaccinated upon arrival, at your expense.
3. Board will be charged at a daily rate in accordance with the schedule listed below. In addition, veterinarian and other fees such as, but not necessarily limited to, hoof trims, x-rays, injections, worming, palpation, ultrasounds, etc. shall be at the owner's expense.
4. Southwind Farm will exercise due diligence in caring for you horse(s). The farm will perform the customary practices for the protection, health and safety of all animals in its care. However, Southwind Farm, its manager, agents, servants and/or employees can not assume liability for illness, accidental injury, disability or death suffered by an animal in our care. The undersigned owner consents to waive all and every claim for damage resulting from any illness, injury or death.
5. Any charges incurred while the horse is being boarded MUST be paid prior to the release of the horse. Overdue accounts will be charged a late fee of 1.5% per month. Failure to timely pay any amounts due Southwind Farm pursuant to the agreement, the undersigned shall in addition thereto pay all reasonable attorney fees incurred by Southwind Farm in connection with the collection thereof to the fullest extent permitted by applicable law.
6. If one owner signs this agreement, when multiple owners own the horse(s), the terms and conditions of this agreement will bind all owners. If an agent for the owner(s) signs this agreement, then the terms and conditions of this agreement will bind the agent and all owners.
7. If any horse is sold or transferred between owners while being boarded at Southwind Farms, the original owner(s) MUST notify Southwind Farm of the change in writing, within 10 days of the date of the change of ownership. If there is any change of ownership or a lease, and Southwind Farms is not notified of the change of ownership or lease, the horse(s) will remain at Southwind Farm under the New Jersey Stableman's Lien Law until all charges are paid in full.
8. This agreement governs the boarding of all horses, even if the horse(s) boarded are not listed at the top of this agreement. I hereby permit Southwind Farm to verify ownership of my horse(s) with the United States Trotting Association, Columbus, Ohio and/or Standardbred Canada, Mississauga, Ontario, Canada.
9. The laws of the State of New Jersey govern this agreement.
10. All palpations, ultrasounding, vaccines, breeding and treatments will be administered VIA veterinarian technicians under the supervision of our veterinarian. We are not liable for any injuries to horses while they are in our care. All boarding animals in need of emergency care will be sent directly to the nearest clinic for care. We use Mid-Atlantic Equine clinic for any emergency treatments.
